ORDINANCE NO 2 , 1963

AN ORDINANCE PROVIDING FOR THE TRANSPORTING, CARRYING, CONVEYING, STORING, STOWING, LOANDING OR UNLOADING, OR USE ON BOARD ANY VESSEL OR WATERCRAFT WITHIN YAQUINA BAY, NEW-PORT, OREGON AND PROVIDING PENALTY FOR VIOLATION THEREOF.

BE IT ORDAINED BY THE PORT OF NEWPORT:

- (a) It shall be unlawful to knowingly transport, carry, convey, store, stow, loand or unload, or use on board any vessel or watercraft within the police jurisdiction of the City of Newport and/or the jurisdiction of the Port of Newport, any explosives or other dangerous articles except in accordance with the regulations of the United States Coast Guard, as set forth in "Code of Federal Regulations, Title 46, Part 146, Shipping", dated January 1, 1958, as revised January 1, 1960, one copy of which shall be filed in the office of the Port of Newport, and as filed made a part of this Ordinance.
 - (b) It shall be the duty of the owner, agent or master to notify the Harbormaster of the Port of Newport not less than five (5) days prior to the arrival in port of any vessel or watercraft carrying any such explosives or dangerous articles.
 - (c) No explosives or other dangerous articles shall be handled at any dock, wharf, pier or other place within the harbor not previously approved by each of the following: the Harbormaster, Fire Chief of City of Newport, and the Commissioners of the Port of Newport.
 - (d) It shall be the duty of the Harbormaster, Fire Chief of the City of Newport and the Police Chief of the City of Newport to enforce the provisions of this Ordinance; and they are empowered and directed in case of necessity of when due notice has been given and disregarded to use all the force at their command to prevent any person from violating any of the provisions of this Ordinance.
 - (e) The Harbormaster, Fire Chief of the City of Newport and the Police Chief of the City of Newport hall have the authority to enter upon and inspect any mill, warehouse, shipyard, dock, boat, vessel, watercraft or structure, either fixed or floating, at all times in the performance of their duty; and any person interfering with or refusing any such entry shall be guilty of violation of this ordinance.
 - (f) Any violation of this Ordinance shall be punishable upon conviction by a fine of not to exceed Five Hundred (\$500.00) Dollars or imprisonment in jail not to exceed Thirty (30) days or by both such fine and imprisonment not to exceed the maximums herein set forth.

It being deemed that this Ordinance is necessary for the immediate health, peace and safety of the people and property within the confines of the boundaries of the Port of Newport, it shall be effective immediately upon adoption.
