

ORDINANCE NO. 1, 1975

AN ORDINANCE AMENDING Ordinance No. 1, 1974, providing that moorage assignment is required; providing that launching and removal without payment of fees prohibited; providing for limitations on vessel storage; and amending section 10.4 regarding penalties.

WHEREAS: The Port of Newport on the 8th day of April 1974 adopted Ordinance No. 1, 1974 which provided for the regulation of Port of Newport facilities; and

WHEREAS: provisions relating to moorage assignment, launching and removal of vessels, vessel storage, commercial activities and the penalty provisions were inadvertently omitted or were not clear; and

WHEREAS: the adoption of provisions relating to the above is necessary for the orderly administration of Port facilities

IT IS THEREFORE ORDAINED by the Port of Newport acting by and through its Commission as follows:

Section 1: COMMERCIAL ACTIVITY ON PORT FACILITIES - deleted per Commission action taken 2/10/75

Section 2: MOORAGE ASSIGNMENT REQUIRED.

No person shall moor or dock a vessel at Port facilities for more than 24 hours without first prepaying moorage fees and obtaining a location assignment from the Port of Newport.

~~Sec~~ Section 3: MOORAGE IN OTHER THAN ASSIGNED LOCATION PROHIBITED.

No person shall moor or dock a vessel in other than an assigned location at Port facilities without first obtaining consent from the Port of Newport.

Section 4: LAUNCHING AND REMOVAL WITHOUT PAYMENT OF FEES PROHIBITED.

No person shall launch or remove a vessel from or on Dock 7 launch ramp or the Port's South Beach properties without prepayment of launch or removal fees.

Section 5: VESSEL STORAGE

No person shall leave or store a vessel on Port facilities without first obtaining consent from the Port and prepaying storage fees.

No person shall store or leave a vessel for the purpose of maintenance or repair without first obtaining consent of the Port and prepaying storage fees if any, and no person shall store or leave a vessel undergoing maintenance or repair for longer than forty-five (45) days without written authority of the Port of Newport.

No person shall store or leave a vessel not undergoing maintenance or repair on Port facilities for longer than 30 days.

Section 6: AMENDING SECTION 10.4 ORDINANCE 1, 1974.

Section 10.4, Ordinance 1, 1974, is amended to read as follows:

10.4 Penalties: Any person violating a provision of this ordinance shall be guilty of a misdemeanor and upon conviction shall be punished by a fine of not more than \$250.00

Section 7: CODIFICATION

The provisions of this Ordinance shall be codified in Ordinance #1, 1974.
